1. Council Regulation (EC) 1698/2005 on support for rural development by the European Agricultural Fund for Rural Development (EAFRD)

Improving the environment and the countryside

Article 36 Measures

Support under this section shall concern:

(a) measures targeting the sustainable use of agricultural land through:

(i) natural handicap payments to farmers in mountain areas;
(ii) payments to farmers in areas with handicaps, other than mountain areas;
(iii) Natura 2000 payments and payments linked to Directive 2000/60/EC;

- (iv) agri-environment payments;
- (v) animal welfare payments;(vi) support for non-productive investments;
- (b) measures targeting the sustainable use of forestry land \dots

Support for AnGR is only a very minor part of EARFD-funding. It is even a minor and specific part of the agri-environmental measures

1. Council Regulation (EC) 1698/2005

Article 39 Agri-environment payments

- Comment:

 Para's 1 to 4 relate to agri-env. measures in general,

 these allow, among others, for payments for keeping animals of an endangered breed (per head premia).

 This had been the only measure explicitly for AnGR in the preceding Council Regulatic
- en the only measure explicitly for AnGR in the preceding Council Regulation 2078/92

There are important restrictions for measures under para's 1 – 4:

• Agri-environment payments can only be <u>granted to farmers</u> who make ... agri-environmental

Article 70 Fund contribution

- 3. The EAFRD contribution rate shall be established for each axis.
 - (b) In the case of axis 2 (improving the environment and the countryside) and axis 4 (Leader) the following ceilings shall apply respectively:

 (i) 80 % of the eligible public expenditure in the regions eligible under the Convergence Objective;

 (ii) 55 % of the eligible public expenditure in the other regions.

As far as the region is eligible under the convergence objective (like Slovenia?) EU pays 80%, 20% is given by the national state.

Article 88 Application of the rules to State aid

Articles 87, 88 and 89 of the Treaty shall apply to support for rural development by Member States.

Article 27

ANNEX II Information to be given by MS 5.3.2.1.4. Agri-environment payments

- the list of local breeds in danger of being lost to farming and the number of breeding females concerned.
 - That number must be certified by a duly recognised technical body or breeder's organisation/association — which must register and keep up-to-date the herd or flock book for the breed. Evidence that the body concerned possesses the necessary skills and knowledge to identify animals of the breeds in danger,
- for conservation of genetic resources in agriculture (Article 39(5) of Regulation (EC) No 1698/2005): types of beneficiaries, of operations and details on eligible costs.

THRESHOLDS FOR ENDANGERED BREEDS (REFERRED TO IN ARTICLE 27(4))

Eligible farm animal species	Thresholds under which a local breed is considered as being in danger of being lost to farming (number of breeding females*)
Cattle	7.500
Sheep	10.000
Goat	10.000
Pigs	15.000
Avian	25.000
Equidae	5.000

^{*} Number, calculated for all Member States, of breeding females of the same breed available for pure-bred reproduction registered in a herd book kept by an approved breeding organisation recognised by the Member State in accordance with Community zodechnical legislation.

3. Draft for a new EAFRD-regulation

A new EARFD-regulation will succeed to COM-Regulation 1698/2005 for the period 2014 -2020

- a draft regulation was officialy presented at 12. October 2011
- the final regulation has to be adopted by Council and EP
- · this is expected not before autumn 2012.

3. Draft for a new EAFRD-regulation

Article 29 Agri-environment-climate is similar to Article 39 in Reg 1698/2005

no change:

- former Art. 39 para 5 on general support for Genetic Resources is now Art. 29 para 9 with the same wording
- payment for keeping animals of an endangered breed is possible as an agri-environmental measure under para's 1 – 8,
- · however the restrictions remain (only farmers, maximum amount 200 €/LU)

slight change:

Article 29 now has 10 para's (before: 5)

3. Draft for a new EAFRD-regulation

New, compared to existing regulation:

- · Member states may finance operation-related expert advice and/or make support under this measure conditional to relevant training
- The Commission shall be empowered to adopt delegated acts concerning conditions applicable to commitments
 - to rear local breeds in danger of being lost to farming
 - as well as the concerning definition of eligible operations under paragraph 9. (i.e. for support to GR)

Comment:

"delegated acts":

- similar to Commission regulations, laying down detailed rules
 however issued by COM without consultation with MS, Council or EP

3. Draft for a new EAFRD-regulation

What can we do, to get optimal support from the new regulation?

- Lobbying for a good final regulation at EU-level
 watch, that the draft is not changed and that sufficient EU-money is reserved for agri-environmental measures
 watch, that the delegated acts allow for effective application of the regulation
 no change in definitions of supported species, thresholds for endangered breeds
 maintain broad letsibility of eligible operations
 reduce administrative restrictions and burden

Lobbying for a good national implementation

National governments will decide, which measures of the EARFD-regulation are implemented (and co-financed by national money), in the period from 2014 on, therefore

- watch, that national programmes to be sent to EU include all measures allowed under Article 29
- watch, that sufficient national money is reserved for that sector take influence, that only effective support operations are implen

1. Council Regulation (EC) 1698/2005

Article 39 Agri-environment payments

Member States shall make available support provided for in Article 36(a)(iv) throughout their territories, in accordance with their specific needs.

Agri-environment payments shall be <u>granted to farmers</u> who make on a voluntary basis <u>agri-environmental commitments</u>. Where duly jussified to achieve environmental objectives, agri-environment payments may be granted to other land managers.

Agri-environment payments cover only those commitments going beyond the relevant mandatory standards established pursuant to Articles 4 and 5 of and Annexes III and IV to Regulation (EC) No 1782/2003 as well as minimum requirements for fertiliser and plant protection product use and other relevant mandatory requirements established by national legislation and dentified in the programme.

These <u>commitments</u> shall be undertaken as a general rule for a <u>period between five and seven years</u>. Where necessary and justified, a longer period shall be determined according to the procedure referred to in Article 90(2) for particular types of commitments.

The payments shall be granted annually and shall cover additional costs and income foregone resulting from the commitment made. Where necessary, they may cover also transaction cost. Where appropriate, the beneficiaries may be selected on the basis of calls for tender, applying criteria of economic and environmental efficiency.

Support shall be limited to the maximum amount laid down in the Annex.
